

Dear members and associated members of Edinna,

EDINNA is the educational network of inland waterway (navigation) schools and training institutes on various levels from 13 European countries. It is the aim of EDINNA to come to a more structured cooperation and to establish a harmonized education, training and certification system for Inland waterway personnel in Europe to ensure high quality of trained staff on board of vessels.

The development of the new European legislative framework continues. Although Edinna supports the initiative it is after an in-depth study of the proposal of the new EU Directive that I come to the conclusion that the text contains proposals that can be improved to reach a more professional vocational education and training environment for the Inland Navigation sector. The objective to have a clear understanding of the requirements education and training institutes must meet in future and improvement of the attractiveness to interest young people to subscribe themselves to one of our educational programmes is not yet at its optimal level. However, as from now it is in the hand of the European Parliament to discuss the proposal and the final text after the European Council reach an agreement last week. Therefore is it of utmost importance that we feed our representatives in the European Parliament with our view and to persuade them that there is room for improvement to get the best out of it to the benefit of the sector.

On May 17th and 18th the so cold drafting group, working on the details of the annexes with respect to the competency tables, met again at the CCNR premises in Strasbourg. All stakeholders worked on the wording of the columns 1 till 4 of the tables. The result of this work will be a concept document that will be discussed in the CESNI/QP meetings for final decision taking.

At the 17th of March the final conference of the Leonardo da Vinci, Life Long Learning programme project 'Train the Trainer course material for Inland Navigation Education and Training' took place at premises of our member De Scheepvaartschool - Cenflumarin located in Antwerp Belgium. By now you should have received the textbook and digital example as the final result of this project. The final product supports the introduction of modern education and training facilities as full mission ship handling simulators not only by installing the equipment but also to train the teachers and instructors whom will work with these tools in a responsible didactical way providing training in the best performance possible.

Finally, we had a fruitful General Assembly at the premises of our member the University of Zilina – Department of Water Transport.

On the 10th and 11th of May 2016, the 10th General Assembly of EDINNA was organised in Zilina, Slovakia.

35 participants from (associated) members of EDINNA had an interactive meeting for two days. On the first day, the board elections for the position of vice-president were conducted. Mr. M. Wieck, Schiffer-Berufskolleg Rhein, was not re-electable. Mr. O. Cupsa, CERONAV, has been re-elected as vice-president of EDINNA.

Mr. K. Paulus, Schiffer-Berufskolleg Rhein has been elected as board member. Schiffer-Berufskolleg RHEIN – one of the founding and always very active members of EDINNA - is a vocational college for Logistics. We offer classes for inland waterway carriers in Germany and Switzerland as well as classes for boat-/shipbuilders and specialists in port logistics from all over the country. At the moment we host about 400 students in Inland Navigation per year. Within the German Dual System the apprentices visit our school once a year for a period of around 13 weeks, while they are working the rest of the year on professional inland vessels all over Europe.

Inland Waterway Transport in the European Union

“Inland navigation: Council agrees its position on a uniform system of professional qualifications ”

On 7 June 2016 the Council adopted a general approach on a draft directive on the recognition of professional qualifications in inland navigation¹. The proposal aims to provide new career prospects and promote the mobility of people working in the sector. It sets up a common system of certificates for the entire crew, from apprentices to boatmasters. Holders of such a certificate will be able to practice their profession on inland waterways across Europe.



This press release was published on the 7th of June 2016 by the European Council and is a big step forwards in the process of the development and acceptance of the STCIN. As a next step, the European Parliament will discuss the legislative proposal and CESNI will continue the development of the annexes.

Just one week later on Wednesday June 15 the draft directive was on the agenda of the European Parliaments' Committee on Transport and Tourism (TRAN). Next to representatives of the social partners, EBU and ETF and representatives of the CCNR and DG Move, Edinna was represented by the chairman and took the opportunity to express the support of Edinna for the draft directive. We are pleased that we reached the current stage. EDINNA expressed suggestions for improvement with regard to the education and training requirements of existing and future IWT crewmembers. Besides questions of the members of parliament that could be answered by the sector representatives the draft was positively received. The TRAN Committee rapporteur will report by the end of 2016.
