In 2008 Mr. Mintjes and myself have been writing the first draft of the Standards of Education, Training and Certification Inland Navigation. In 2009 the second draft was adopted by the team in Platina working on "Jobs and Skills" as a possible approach towards a future harmonised system of inland waterway education and training standards. After years of work with the support of all stakeholders and several projects, like the activities in the field of the Common Expert Group on Professional Qualifications in Inland Navigation, Platina I & II, and the ongoing development in the working groups of CESNI/QP, the proposal for a new EU Directive, on the recognition of professional qualifications in inland navigation and repealing Council Directives 91/672/EEC and 96/50/EC has been adopted by the European Parliament on November 14th 2017.

Although the Parliament adopted the proposal with an overwhelming majority next steps in the legislative procedure have to be taken., This implies that the proposal must be accepted by the European Council which adopted the proposal early December. 20 days after the official announcement of the new legislation the Directive will enter into force. EU member states have 4 years' time to implement the Directive in their national legislation meaning that the Directive must be operational in 2022.

The end result is a political compromise, however overall leads us into a new era within the field of education, training and qualifications offering possibilities to become a professional and competent crew member in the inland navigation.

Now the legislation will enter into force, our Edinna members are faced with the challenge to convert the Directive into their education and training curricula. Next to the general articles of the Directive the most important information for the adjustment of our curricula are mentioned in the Annexes I and II.

- Annex I:
Minimum requirements for age, administrative compliance, competence and navigation time.
- Annex II:
Essential competence requirements

Annex II mentions only the headlines. The tables with the columns 1 & 2 OL ad ML are still being worked upon in CESNI/QP but will be available soon. The documents concerning the practical exams are still under construction.

The announcement of the new directive serves as first step. To be able to convert the Directive into IWT curricula of all education and training institutes the next challenging step has to be taken. For this reason the Edinna board would like to support their members with the implementation of the Directive and as known for this purpose will apply for funding via the Sector Skills Alliance, as part of the Erasmus+ programme. Although the first application was not granted we are in the process of a second attempt. Secondly, we are in consultation with all stakeholders to find possible financing support for the necessary follow-up activities.

I wish all members and Edinna relations an enjoyable season holiday with their family, friends and relatives and look forward to a fruitful cooperation in 2018.

LE SINCP App

Many years ago, some members of EDINNA started to collect typical phrases that are used on board of vessels to e.g. arrange manoeuvres between two inland vessels or to contact VTS centres. This was internally called "Riverspeak". Two years ago the collection was brought to the Police Committee of the Central Commission for the Navigation of the Rhine (CCNR) to check the phrases. All modification requests were made. Therefore CCNR (www.ccr-zkr.org) supports the use of this phrases in Inland Navigation.

For this reason the phrases formerly known as "riverspeak" are now called: Standard Inland Navigation Communication Phrases (short: SINCP). They are available in English, French, Dutch and German.

With the financial aid of the Interreg-Project "Ler(n)ende Euregio" (www.lerende-euregio.com) the Edinna-Member Schiffer-Berufskolleg RHEIN has now brought the phrases into a mobile-App for Android and Apple devices. This App is free for everyone.



There are more than 1000 communication phrases in the four languages as well as images with technical terms. Translations are in all directions possible. Depending on the device it will read the phrases in all languages as well aloud.

Competency Based Inland Waterway Transport Education & Training (IWTCOMP)

On the 1st of October 2016, the kick-off meeting of the IWTCOMP project was organised in Rotterdam. The IWTCOMP project focusses on the implementation of competency based education and training for the inland waterway transport sector, following the new legislation concerning professional qualifications in inland navigation. During the lifetime of the project, a.o., train-the-trainer material will be developed facilitating the implementation of competency based education at institutional level. The consortium consists of the following members of EDINNA:

The first two concrete deliverables are almost finished. As a first step, the EQF levels have been connected with the tables of competencies. A comparison of the different outcomes on a national level will follow shortly. Another important task of the IWTCOMP project is to draft a catalogue of best practices on competency based education and training, to guide the members of EDINNA with the implementation of the tables of competences, which will form an integral part of new legislation soon.
